

# Briefing Note for Editorial Advisory Group

## January 2022

### Inactivation of concepts related to legality of abortion

#### Purpose

For discussion and approval on the inactivation of concepts with descriptions that refer to the legality of an abortion procedure.

#### Background

Recent discussions in the Editorial Advisory Group (EAG) and a formal request from the Argentina National Release Center (NRC) have suggested for the inactivation of concepts linked to the legality of procedures related to the interruption of pregnancy (see suggested inactivations below). The Argentina NRC has prepared supporting documentation (attached) with the issues of these concepts and reasons for inactivation. In brief:

- The concepts correspond to a legal status of a procedure which will be different in all countries, states, territories, etc.
- Due to the varied regulations of abortion procedures, SNOMED CT terms referencing illegal/legal can impact semantic interoperability and quality of records as these will reflect different meanings in different jurisdictions.
- These concepts are in violation of current SNOMED CT editorial policy.
  - “Concepts referring to regulatory status or characterization (e.g., over-the-counter) are out of scope for the International Release. Meaning may vary by jurisdiction and may not be consistent internationally.” (See [Out of Scope policy](#)).
- Due to the reasons above, the notion of ‘legal’ or ‘illegal’ can be added by an Extension if deemed necessary.

It is proposed that these concepts referencing the legality of the procedure are inactivated.
