Initial, brief discussion on post-coordination of severity of glaucoma:

- Hodapp-Anderson-Parrish staging system and ICD-9/10 staging definitions discussed
- Hodapp-Anderson-Parrish staging system: has 5 stages, but no pre-perimetric stage or indeterminate stage
- ICD-9/10: concern that eyes with any visual field defect would be categorized as Moderate-stage glaucoma as Mild or early-stage glaucoma is defined as no visual field abnormalities in the classification

Further work to be done:

- IR+AK to work up a proposal for post-co-ordination terms on severity of glaucoma and for discussion at next meeting
- To promote education and awareness about the appropriate nomenclature regarding historical terms like “Acute angle closure glaucoma”, “Haemolytic glaucoma”, “Phacolytic glaucoma”
- Update and discuss proposed Preferred Glaucoma Diagnosis Reference Set at next meeting
