3 Scope of construction work:

- Concepts where the FSN includes the word 'Unilateral'.
 - The concept will be inactivated with the inactivation value of |Ambiguous|.
 - Historical associations will be made to the lateralised concepts that represent the meaning explicitly.
 - Where the lateralised concepts do not exist they will be created.
- Concepts where the FSN represents a valid meaning e.g. Lobectomy of X (procedure) but one or more of the synonyms includes the term 'unilateral',
 - The description will be inactivated with the inactivation value |Not semantically equivalent|.
- Work will be done in small batches per hierarchy.
- Out of scope: 'Hemi' and 'mono' concepts.
