# Host the 2026 October Business Meetings & SNOMED CT Expo!

Once annually in October, SNOMED International and an individual Member country work together to hold an internationally-attended SNOMED CT event. The event is comprised of a four-day <u>Business Meeting</u> and a two-day <u>SNOMED CT Expo</u>, supplemented with regional and culturally focused social activities.

The Business Meetings allow SNOMED International governance and advisory bodies, such as the General Assembly, Management Board, Member Forum, Advisory, Working, Project, User and Clinical Reference Groups, to meet face-to-face and also gain exposure regarding the host country's health and digital health environment.

By contrast, the Expo is a more externally-oriented event aimed at showcasing global SNOMED CT implementation successes and experiences.

With each event cycle a new call for hosts is made, encouraging Member consideration to submit a proposal to host the October events.

### **HOW DOES THE SELECTION PROCESS WORK?**

### Call for Expression of Interest:

Call to SNOMED International Member countries to submit expressions of interest to host the October 2026 Business Meetings and SNOMED CT Expo events.

Deadline to Submit Verbal Expressions of Interest for Review by Dec 23, 2024.

### **Request for Formal Proposals:**

SNOMED International will shortlist Member hosts for 2026 with an invitation to prepare a formal proposal.

## Submit Formal Proposals by February 7, 2025, with guidance by SNOMED International

Proposals will require detailed information as outlined in the <u>Host Country Proposal Requirements</u> document.

### **Review of Formal Proposals:**

SNOMED International & Management Board, by the end of February 2025

Successful October 2026 Member host country will be decided upon and announced at the April 2025 Business Meetings.
