I. Welcome and Call to Order

Bonnie Westra called the meeting to order at 6:06pm central.

II. Approval of Minutes – May 21, 2012

Minutes approved as presented.

III. Member Updates

AMIA: Reported the AMIA 2012 Annual Symposium November 3 -7, 2012 is seeing tremendous success; sessions of note include the AMIA NIWG Tutorial on Saturday, the NIWG event on Sunday morning and Judy Murphy presenting a keynote session. Additionally, October 30 – November 7 has been designated as *Informatics Week* by Chicago’s Mayor.

ANIA: Reported that they are undergoing transition with an association management company; and has released a new website (same url www.ania.org) and a new webinar library. Note: call for abstracts for the May 2-4, 2013 ANIA Conference in San Antonio.

AORN: Reported that they just held their first ever Nursing Informatics Boot Camp! (See www.aorn.org)

CNC: Reported that they are building a new website and finishing the sixth edition of NIC.

CPMRC: Reported that Michelle Troseth had the opportunity to present a session on “Roles, Competencies, Skills, Organizations, and Legislative Aspects” at the recent Quality and Safety Education for Nurses (QSEN) Conference. (See: www.aacn.nche.edu/qsen-informatics)

HIMSS: Reported that they are in process of planning the HIMSS13 Nursing Informatics Symposium in New Orleans for March 2 & 3; please note a call for posters has been issued for the HIMSS13 Nursing Informatics Symposium. (See www.himssconference.org)

MNRS: Accepted several informatics submissions for a presentation within the guaranteed symposium, "The Contribution of Health Information Technology in Improving Patient Care Delivery and Outcomes." The MNRS Conference will be held March 7-10 in Chicago.

NENIC: Held a very successful Fall evening program and served as a successful co-host along with Partners Healthcare and the Organization of Nursing Leaders on the HIMSS Nursing Informatics Institute. Additionally, they are busy planning their annual Spring Conference.

Omaha System: Reported that they are over 2,000 members strong and busily preparing for the 2013 Omaha Conference.

ONS: Reported that they held a successful online nursing informatics event for their membership, in collaboration with HIMSS. Liz Evans and Christel Anderson volunteered to author an article on the event for *CIN ANI Connections*.

SNOMED: Reported that they are currently gathering and indexing historical information from the early SNOMED days. Additionally the work with the National Library of Medicine is continuing to progress. (See: http://www.nlm.nih.gov/research/umls/Snomed/snomed_main.html)

TIGER: Michelle Troseth, co-chair, shared that TIGER has launched their Virtual Learning Environment. (See www.thetigerinitiative.org)

IV. Potential ANI Activities

ANI Governing Directors discussed potential activities that ANI could engage in related to Nursing Informatics Competencies, e.g. updating previous works and harmonizing current efforts. Governing Directors agreed that ANI should serve as a forum where we can report "out" and educate on applicable nursing informatics including, but not limited to: Stagers, TIGER, ANA work, ANCC role delineation, AMIA's work on health informatics and the QSEN Competencies. Christel Anderson and Judy Murphy will work with getting all of the stakeholders connected to explore next steps.

A discussion was held on the Nursing Information and Data Set Evaluation Center (NIDSEC). The following individuals volunteered to serve on a group that would explore opportunities for NIDSEC: Bonnie Westra (lead), Carol Bickford, Susie Hull, Janice Kelly, Michelle Troseth and Vicki Vallejos.

V. Consumer eHealth Task Force

The Consumer eHealth Task Force mobilized an event to support the ANI eConsumer Pledge: *Ask for Your e-Health Record Week* during September 10-14. This was held as a social networking campaign. Each ANI member was encouraged to leverage a week of experience and conversations with their membership.

VI. Engagement Updates and Opportunities for Action

Meryl Bloomrosen reported on the following opportunities for ANI engagement:

- **ONC launches HIT-FACA Workgroup Application Database.** ONC has developed an online database system to allow anyone with an interest in contributing his or her expertise in the numerous aspects of HIT to submit their information for future consideration for Health Information Technology Federal Advisory Committee (HIT- FACA) workgroup membership. Whenever a new workgroup is formed, or as current workgroups experience turnover, ONC use this resource first to identify potential workgroup members. - **ONC Releases 2014 Draft Test Methods for Public Review and Comment.** The Office of the National Coordinator for Health IT (ONC) released the 2014 Edition draft Test Methods (test procedures, tools, and applicable test data and files.) Wave one was released for public review and comment on Friday, September 7. All Test Methods will undergo public review and comment before being finalized and approved by ONC for use in testing and certification. The final set of Test Methods is expected to be available for use in early 2013. Comments and suggestions should be submitted to ONC.Certification@hhs.gov.
- **IOM Releases Report: Best Care at Lower Cost: The Path to Continuously Learning Health Care in America.** The report points out that emerging tools like computing power, connectivity, team-based care, and systems engineering techniques—tools that were previously unavailable—make the envisioned transition possible, and are already being put to successful use in pioneering health care organizations. <http://www.iom.edu/Reports/2012/Best-Care-at-Lower-Cost-The-Path-to-Continuously-Learning-Health-Care-in-America.aspx>
- **PCORI launches its second cycle of funding requests.** PCORI Funding Announcements (PFAs) correspond to four of the five areas of focus outlined in its National Priorities for Research and Research Agenda. VII. ANI Emerging Leaders Project Update

Sarah Collins provided an update on her project: *“Conceptual Framework for Hospital Governance to Advance Nursing Informatics and Innovation”*. This project will develop a conceptual framework for the organizational structure of nursing informatics within a hospital system for the development and implementation of system-wide innovative informatics tools and interventions used by nurses.

Methods: Semi-structure telephone interviews with nursing informatics leaders at hospitals throughout the country. Data analysis: thematic analysis of interview data.

VIII. ANI Innovator Profile

Vicki Vallejos and Linda Burnes Bolton have participated in the ANI Innovator Profile Project. This project is intended to increase the awareness & visibility of the ANI membership organizations.

Process:

Jennifer Roniger (HIMSS) will work with each Governing Director who is currently listed on the ANI Roster and set up an interview with Joyce Sensmeier to review a series of questions. Each individual ANI Innovator Profile will be documented in a standardized format, and posted on the ANI web site.

IX. ANI Engagement Survey Results

Karen Greenwood reported the findings of the ANI Engagement Survey Results. After discussion, the Governing Directors agreed to develop a new Task Force for policy comments and utilize this opportunity to mentor a group through the development of a call for comments. Meaningful Use Stage 3 provides the first opportunity for us to do this.

The nursing LOINC subcommittee is a subcommittee of the Clinical LOINC committee chaired by Stan Huff and Clem McDonald. The chair of the nursing LOINC subcommittee is Susan Matney. Membership of the committee is informal and includes those who have submitted content or been involved in the nursing content within clinical LOINC.

On December 18, 2002, the American Nurses Association (ANA) Committee for Nursing Practice Information Infrastructure recognized the Logical Observation Identifiers Names & Codes (LOINC) as the thirteenth terminology for use by nursing. This terminology was originally created to define universal names and codes for laboratory findings. In the past ten years it has been expanded to include other clinical measurements including assessment items of relevance to nursing such as vital signs, obstetric measurements, clinical assessment scales, assessments from standardized nursing terminologies, and research.

Membership of the Clinical LOINC Nursing subcommittee is voluntary and open to any nurse who would like to be involved including LOINC users, content developers and domain experts. There is not an official count of members but more than 20 nurses have officially submitted content to the database.

Nursing LOINC Subcommittee Mission:

To provide LOINC codes for observations at key stages of the nursing process, including assessments, goals, and outcomes, and to meet the needs for administrative and regulatory data related to nursing care.

Nursing LOINC Subcommittee of Scope of Responsibility:

1. Triage all content related to nursing
2. Assist with understanding
3. Go after "Gaps"
 - a) Goals
 - b) Complete nursing assessments
4. Submit content to the Clinical LOINC committee in a "fit" condition to use

- a) Put out with associated codes and modeling
- 5. Disseminate new content in the literature
- 6. Solicit input
 - a) Disseminate possible starter set for nurses to review, such as a vital signs assessment.

About articles that are submitted:

The **ANI Connection** will appear monthly in the online version of *CIN: Computers, Informatics, Nursing*. Previously, **ANI Connection** encompassed four pages in each print issue (six times per year). Now, the **ANI Connection** will be published monthly (twelve times) which should provide more exposure to ANI.

Online publication is not as constricted by pages as print, thus the **ANI Connection** articles can be more flexible in terms of length.

Schedule: Articles for the issue two months in advance must be submitted by the 15th of the month. So, for example, the **ANI Connection** article for May 2013 must be submitted to the production team by March 15, 2013. Because the **ANI Connection** will be published monthly, an article must be submitted by the 15th of every month.

Process: The editorial office for *CIN* will keep a running list of articles that are “in the pipeline” for the **ANI Connection**. “In the pipeline” means that they have either been submitted or proposed. Leslie will share this list at the monthly conference call of the ANI Governing Directors as a standing agenda item. The group can review the list and identify which article will be submitted for the upcoming issue of the journal. The scheduling works well because the monthly call is scheduled for the first Tuesday of the month which falls before the 15th, giving time for the article to have a final editing prior to submission.

Format: While length is no longer an issue, we still require articles to be submitted according to *CIN* submission guidelines. Please note the following:

- Format: Word document. Do not submit PDFs. Please double space and indent each paragraph with a tab (do not use the space bar). Do not overly format the article (fancy fonts, etc.).
- Title: Please include a title for the article. Descriptive is best.
- Author(s): Include the author’s name(s) and credentials as you would like them to appear in the journal.

- Abstract: **DO NOT INCLUDE**. ANI Connections articles do not have an abstract.
- References (if applicable): *CIN* uses AMA format (Style Manual of the American Medical Association, 10th edition). Please do not submit manuscripts with references in APA format. AMA uses superscripted numbers. The reference list is in numerical format according to the order of appearance of the references in the paper. If you have a reference list, the references must be cited in the text.
- Tables: Use the table feature in Word to create tables. Include them at the end of the manuscript. Tables should be single spaced.
- Figures, photographs: Attach as separate documents. Contact Susan at susan@medesk.com for details on format.

INFORMATION ABOUT THE ANI STEERING COMMITTEE

The ANI Steering Committee consists of the two co-chairs and 3 Members at Large and is responsible for the management of the property and business of ANI. The Steering Committee serves as the day to day contacts for implementation of goals and objectives set forth by the Governing Directors.

Members at Large: The Governing Directors will nominate and elect three people to serve as Members at Large on the Steering Committee based on the following guidelines:

- Members at Large are to be from three different participating organizations outside of AMIA and HIMSS (MNRS and NENIC have an individual on the committee for the 2013-2014 term).
- Organizations with someone serving on the Steering Committee can appoint an additional representative to serve as the Governing Director.
- Members at Large will serve a 3 year term of office with the possibility of re-election up to a maximum of 2 terms.). The current steering committee member whose term expires in June (NCNA CONI) is eligible to run for a second term.

Responsibilities of the Steering Committee include:

- Attendance at 2 in-person meetings annually
- Participation in 2 Town Hall meetings (via conference call) annually
- Participation in monthly Steering Committee calls
- Active participation in the day to day business of ANI

Requests for Comment/Information/Guidance

- Last year, the Health Resources and Services Administration (HRSA) funded the American Academy of Pediatrics (AAP) to develop a library of age-appropriate messages for parents and caregivers of children ages 1-5 based on the Bright Futures Guidelines for Health Supervision of Infants, Children and Adolescents. The library of messages (named TXT4Tots) was developed in both English and Spanish and the messages focus on nutrition, healthy eating and physical activity. HRSA has released a Request for Information (RFI) to solicit ideas and information related to ways to work with interested partners to disseminate and apply TXT4Tots. New Regulations

- **HIPAA Modifications.** On Friday, January 25, 2013, the Office for Civil Rights (OCR) of the U.S. Department of Health and Human Services (HHS) published the final rule, entitled “Modifications to the HIPAA Privacy, Security, Enforcement, and Breach Notification Rules under the Health Information Technology for Economic and Clinical Health Act and the Genetic Information Nondiscrimination Act; Other Modifications to the HIPAA Rules” (Omnibus Rule), 78 Fed. Reg. 5566. The Omnibus Rule will be effective on March 26, 2013, with a compliance period of 180 days, requiring compliance as of September 23, 2013. <http://www.hhs.gov/news/press/2013pres/01/20130117b.html>

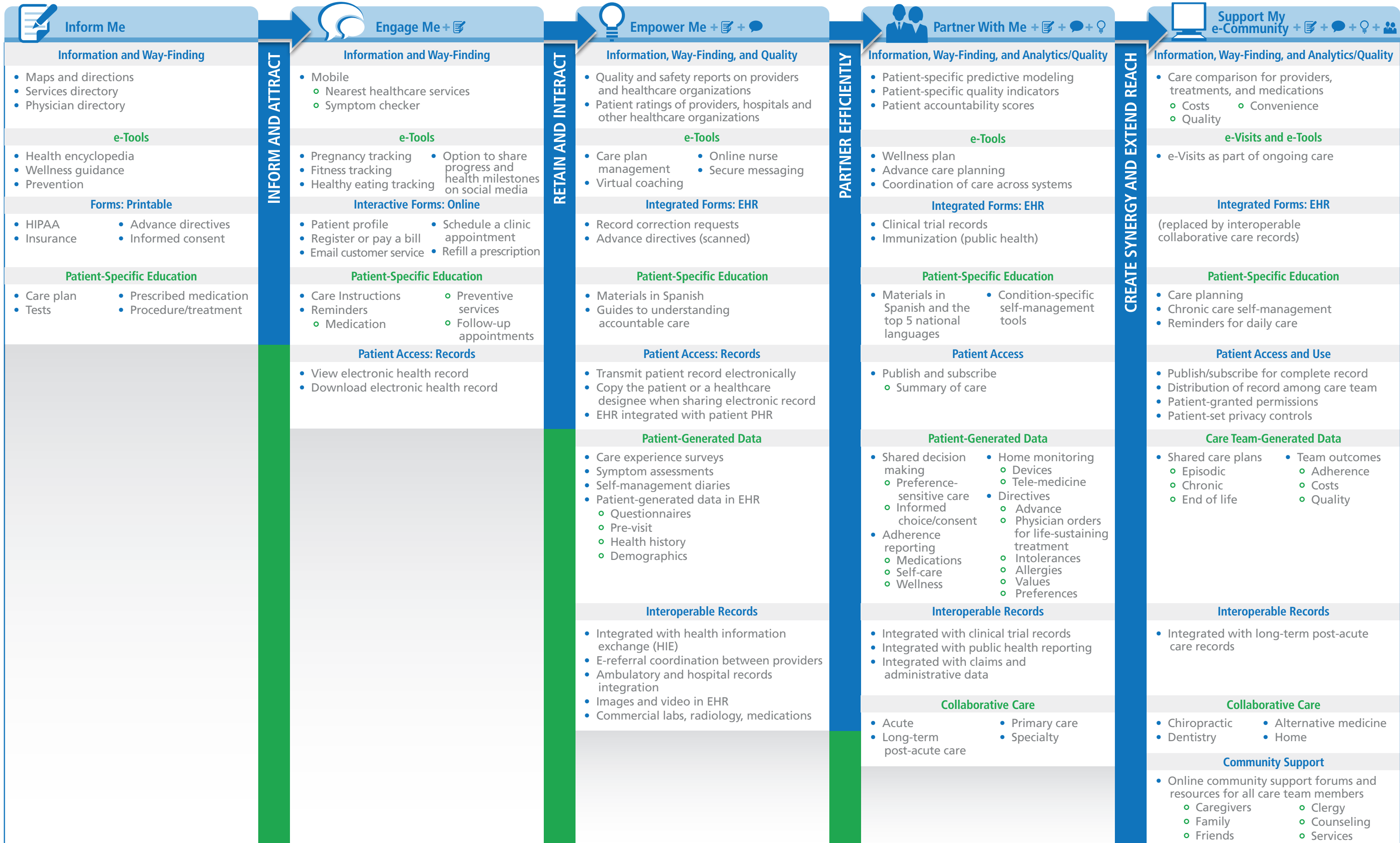

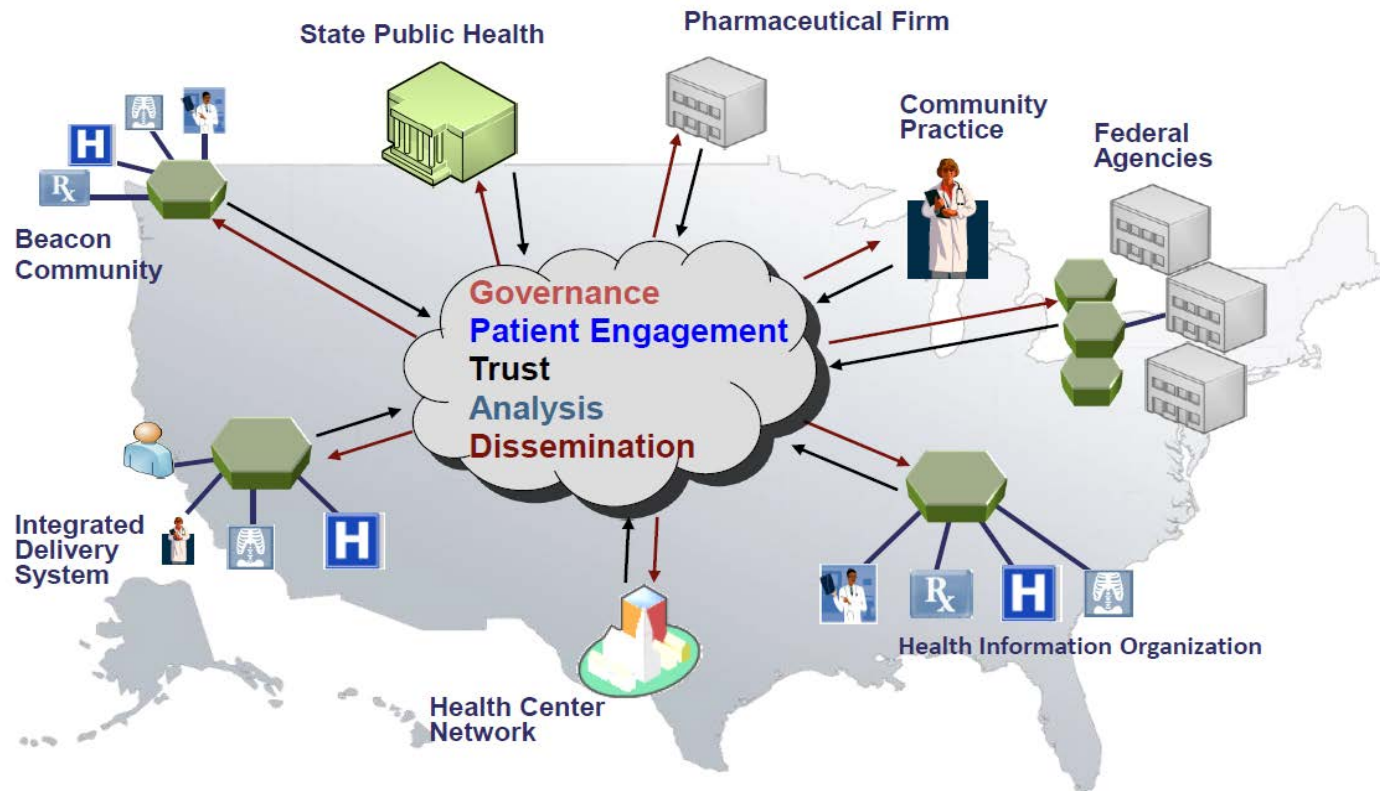

LHS Summit and Call to Action

- An invitational Learning Health System Summit was convened by the Joseph H. Kanter Family Foundation, in Washington, DC on May 2012.
- The goal of a Learning Health System (LHS) is to efficiently and equitably serve the learning needs of all participants, as well as the overall public good.
- The LHS Summit and subsequent efforts are complementary to the IOM report/guidance.
- Intent is to build stakeholder engagement, community support and begin to harmonize the infrastructure.

A Learning Health System Will Make These Things Possible

- Nationwide post-market surveillance of a new drug quickly reveals that personalized dosage algorithms require modification. **A modified decision support rule is created and is implemented in EHR systems.**
- During an epidemic, new cases reported directly from EHRs. **As the disease spreads into new areas, clinicians are alerted.**
- A patient faces a difficult medical decision. **She bases that decision on the experiences of other patients like her.**

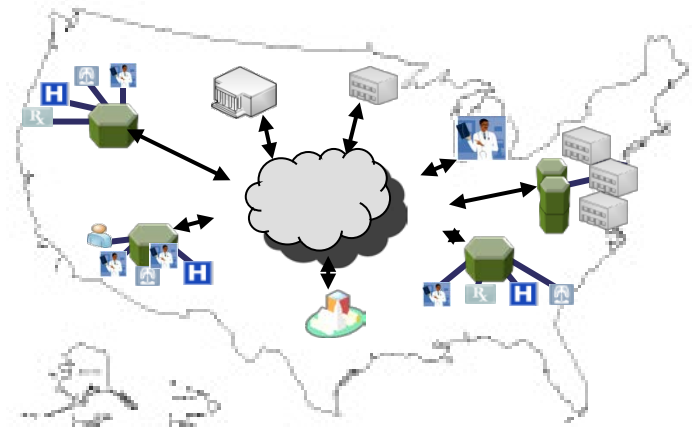

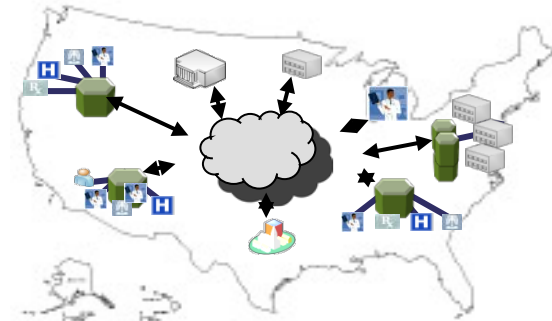
